

Power Home Solar Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The Power Home Solar Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina and South Carolina who, prior to 10/1/20 are twenty-one (21) years of age or older and a homeowner (hereafter, each an "Eligible Entrant"). Employees, officers, directors, agents and representatives of Panthers Football, LLC and Power Home Solar (hereafter, "Sponsors"), the National Football League, its member professional football clubs, NFL Ventures, L.P., and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void where prohibited by law. All applicable federal, state & local laws apply.

To enter, entrant must be a member of FanCompass.com. Registration is free. If entrant is not a member, entrant may register by clicking on the link as indicated on the Sweepstakes entry page and following the instructions. During registration, entrant will be asked to provide his or her first and last name, email address, birth date, gender (optional), to select a user name and password and accept the Terms of Use. Those who are already members of FanCompass will be asked to enter their account information (email address or user name, and password) to enter. As a member, entrant may enter the Sweepstakes by logging in to the system with entrant's current username and password. Entrants are responsible for ensuring that all contact information is up-to-date and accurate.

2) Promotion Period: Sweepstakes starts 10:00:00 am Eastern Time ("ET") on 10/1/20 and ends at 11:59:59 pm ET on 10/29/20 (hereafter, "Promotion Period").

3) How to Enter: During the Promotion Period, visit www.panthers.com/solarpanels and complete and submit the registration form to receive one (1) entry ("Entry").

Entries must be received by 11:59:59 pm ET on 10/29/20 to be eligible. **Only one (1) entry per email address will be accepted throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsors and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsors' sole discretion and in accordance with these Official Rules) are void. In the event of a dispute as to the identity of any entrant, such entrant will be deemed, to be the "authorized account holder" of the e-mail address submitted at the time of entry provided he/she is eligible according to these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to the e-mail address by an Internet access provider, online service provider or other organization (e.g., a business, educational institution, etc.) which is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, destroyed or undelivered entries, emails, entry information or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, or the announcement of the prize; or for any injury or damage to entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official

Rules or other Sweepstakes-related materials. Sponsors reserve the right, in their sole discretion, to void any entries of Eligible Entrants whom Sponsors believe have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

4) Winner Selection: One (1) Grand Prize winner will be randomly selected from among all entries received throughout the Promotion Period. Drawing will be conducted by Sponsors on or about 10/30/20. Odds of winning the prize depends upon the total number of eligible entries received throughout the Promotion Period. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsors and judges, which will be final and binding in all respects. The potential winner will be notified by telephone and/or email and may be required to execute and return an Affidavit of Eligibility, Liability, and (where legal) Publicity Release along with any other documentation or proof of home ownership required by Sponsor(s) within two (2) days of date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsors' discretion and time permitting, awarding of prize to an alternate winner.

5) One (1) Grand Prize: The Grand Prize winner will receive: i) thirteen (13) Power Home Solar manufacturer solar panels; ii) one (1) 8.6k Generac battery module; and iii) installation and labor of the provided solar panels. Approximate Retail Value ("ARV"): \$47,832. If the winner is unable to accept the prize, winner will receive a prize of equal or greater as determined by Sponsors in their sole discretion. Actual/appraised value may differ at the time of prize award. All prize details are at the sole discretion of Sponsors. Costs and expenses associated with the acceptance and use of the prize not specified herein as being awarded, including, but not limited to, federal, state and local taxes, are winner's sole responsibility.

6) Miscellaneous: No transfer, assignment, cash redemption, or substitution of the prize (or portion thereof) is permitted except by Sponsors who reserve the right to substitute prize (or applicable portion thereof) with one of comparable or greater value, at its sole discretion. Eligible Entrants agree, by entering, that 1) Sponsors and their designees may use (unless prohibited by law), Eligible Entrant's name, city and state of residence, photograph and/or likeness for advertising, trade and/or any other purposes in any media now or hereafter known throughout the world in perpetuity, without further compensation, permission or notification, 2) Sponsors reserve the right to conduct a background check and entry in the Sweepstakes constitutes Eligible Entrant's permission for Sponsors to conduct such background check, provided that, to the extent additional authorization is necessary under law, Eligible Entrants shall authorize such check. Sponsors reserve the right (at their sole discretion) to disqualify any entrant based on the results of the background check or failure of the entrant to properly authorize such check, and 3) the Released Parties shall have no liability and will be held harmless by Eligible Entrant for any claim, action, liability, loss, injury or damage to Eligible Entrant or any other person or entity, including, without limitation, personal injury or death to Eligible Entrant or any other person or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of the prize or participation in this Sweepstakes. Sponsors reserve the right, in their sole discretion, to modify, suspend, and/or terminate this Sweepstakes (or portion thereof) for any reason, including should virus, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness or proper play of the Sweepstakes and, in the case of termination, at its discretion, select the winner from among all eligible non-suspect entries received prior to the event that required such termination.

Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with participating in this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.
