

25th Season Patch Giveaway

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The 25th Season Patch Giveaway (hereafter, "Sweepstakes") is open to legal permanent residents of the fifty (50) United States or District of Columbia who, prior to 8/21/19 are twenty-one (21) years of age or older (hereafter, "Eligible Entrants"). Those who are already members of FanCompass will be asked to enter their account information (email address or user name, and password) to enter. As a member, entrant may enter the Sweepstakes by logging in to the system with entrant's current username and password. 3) How to Enter: Visit <https://contests.panthers.com/contest/3646> and execute the FanCompass member sign-in and complete and submit the registration form to receive one (1) entry ("Entry").

Entries must be received by 11:59:59 pm ET on 9/13/19 to be eligible. **Only one (1) entry per person per email address will be accepted throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The potential winner will be notified by telephone and/or email and may be required to execute and return an Address Verification Form within two (2) days of date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.
