

Panthers Experience of a Lifetime Giveaway

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The Panthers Experience of a Lifetime Giveaway (hereafter, "Sweepstakes") is open to legal permanent residents of North and South Carolina, prior to 10/17/19 are twenty-one (21) years of age or older (hereafter, each an "Eligible Entrant"). Employees, officers, directors, agents and representatives of Panthers Football, LLC (hereafter, "Sponsor"), the National Football League, its member professional football clubs, NFL Ventures, L.P., and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. To enter, entrant must be a member of FanCompass.com. Registration is free. If entrant is not a member, entrant may register by clicking on the link as indicated on the Sweepstakes entry page and following the instructions. During registration, entrant will be asked to provide his or her first and last name, email address, birth date, gender (optional), to select a user name and password and accept the Terms of Use. Those who are already members of FanCompass will be asked to enter their account information (email address or user name, and password) to enter. As a member, entrant may enter the Sweepstakes by logging in to the system with entrant's current username and password. Entrants are responsible for ensuring that all contact information is up-to-date and accurate.

2) Promotion Period: Sweepstakes starts 3:00:00 pm Eastern Time ("ET") on 10/31/2019 and ends at 11:59:59 pm ET on 11/10/2019 (hereafter, "Promotion Period").

3) How to Enter: During the Promotion Period, visit <https://contests.panthers.com/contest/3751> and complete and submit the registration form to receive one (1) entry ("Entry").

Entries must be received by 11:59:59 pm ET on 11/10/2019 to be eligible. **Only one (1) entry per email address will be accepted throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. Drawing will be conducted by Sponsor on or about 11/11/2019. Odds of winning the Grand Prize depends upon the total number of eligible entries received throughout the Promotion Period. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. The potential winner will be notified by telephone and/or email and may be required to execute and return an Affidavit of Eligibility, Liability, and (where legal) Publicity Release within two (2) days of date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

5) One (1) Grand Prize: The Grand Prize winner will receive a 2 day/1 night stay for winner and (1) guest to Charlotte, NC from 11/16/19 to 11/17/19 to attend the Carolina Panthers home game against the Atlanta Falcons currently scheduled to take place on 11/17/19. Trip includes i) round trip coach class air transportation from a major U.S. gateway airport nearest winner's residence in the U.S. to Charlotte, NC; ii) one (1) standard double occupancy hotel accommodation (one (1) room) for 1 night; iii) two (2) pre-game hospitality passes; and two (2) tickets to the game. Approximate Retail Value ("ARV"): \$4,300.
