

Player Arrival Experience Giveaway

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The Player Arrival Experience Giveaway (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina and South Carolina who, prior to 9/30/19 are twenty-one (21) years of age or older (hereafter, each an "Eligible Entrant"). Employees, officers, directors, agents and representatives of Panthers Football, LLC (hereafter, "Sponsor"), the National Football League, its member professional football clubs, NFL Ventures, L.P., and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside of North Carolina, South Carolina, and where prohibited by law. All applicable federal, state & local laws apply.

To enter, entrant must be a member of FanCompass.com. Registration is free. If entrant is not a member, entrant may register by clicking on the link as indicated on the Sweepstakes entry page and following the instructions. During registration, entrant will be asked to provide his or her first and last name, email address, birth date, gender (optional), to select a user name and password and accept the Terms of Use. Those who are already members of FanCompass will be asked to enter their account information (email address or user name, and password) to enter. As a member, entrant may enter the Sweepstakes by logging in to the system with entrant's current username and password. Entrants are responsible for ensuring that all contact information is up-to-date and accurate.

2) Promotion Period: Sweepstakes starts at 10:00:00 am Eastern Time ("ET") on 10/1/19 and ends at 11:59:59 pm ET on 12/1/19 (hereafter, "Promotion Period"). The Promotion Period will be divided into three (6) entry periods as indicated in the chart below (hereafter, each an "Entry Period").

3) How to Enter: During each Entry Period, following receipt of the email invitation sent by Sponsor on the Start Date as indicated in the above chart, Eligible Entrants will be directed to i) click on the link provided in the body of the email; ii) log into their FanCompass account; and iii) complete and submit the registration form to receive one (1) entry.

Entries from one Entry Period will not carry forward to subsequent Entry Periods. Entries must be received by the end date in each Entry Period to be eligible. **Only one (1) entry per email address will be accepted throughout the Promotion Period. Entries received in excess of the stated**

limitation will be void. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) are void. In the event of a dispute as to the identity of any entrant, such entrant will be deemed, to be the "authorized account holder" of the e-mail address submitted at the time of entry provided he/she is eligible according to these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to the e-mail address by an Internet access provider, online service provider or other organization (e.g., a business, educational institution, etc.) which is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, destroyed or undelivered entries, email invitations, emails, entry information or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, emails or the announcement of a prize; or for any injury or damage to entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of Eligible Entrants whom Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

4) Winner Selection: Potential winners will be randomly selected from among all eligible entries received during each applicable Entry Period. Drawing will be conducted by Sponsor on or about the dates indicated in the above chart. Odds of winning a prize depends upon the total number of eligible entries received throughout the Entry Period. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. The potential winners will be notified by telephone and/or email and may be required to execute and return an Affidavit of Eligibility, Liability, and (where legal) Publicity Release within two (2) days of date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

5) Twenty (20) Grand Prizes: Each Grand Prize winner will receive access for winner and one (1) guest to the player arrival experience prior to a Carolina Panthers home game to be determined by Sponsor in its sole discretion. Due to the unique nature of the experience, an approximate retail value could not be determined. All prize details are at Sponsor's sole discretion. Prizes are awarded "as is" without any warranty or guarantee, either express or implied by Sponsor. Costs and expenses associated with the acceptance and use of prize not specified herein as being awarded, including, but not limited to, federal, state and local taxes, food, beverages, and transportation are each winner's sole responsibility.

6) Miscellaneous: No transfer, assignment, cash redemption, or substitution of a prize (or portion thereof) is permitted except by Sponsor who reserves the right to substitute prize (or applicable portion thereof) with one of comparable or greater value, at its sole discretion. Eligible Entrants agree, by entering, that 1) Sponsor and its designees may use (unless prohibited by law), Eligible Entrant's name, city and state of residence, photograph and/or likeness for advertising, trade and/or any other purposes in any media now or hereafter known throughout the world in perpetuity, without further compensation, permission or notification, 2) Sponsor reserves the right to conduct a background check and entry in the Sweepstakes constitutes Eligible Entrant's permission for Sponsor to conduct such background check, provided that, to the extent additional authorization is necessary under law, Eligible Entrants shall authorize such check. Sponsor reserves the right (at its sole discretion) to disqualify any entrant based on the results of the background check or failure of the entrant to properly authorize such check, and 3) the Released Parties shall have no liability and will be held harmless by Eligible Entrant for any claim, action, liability, loss, injury or damage to Eligible Entrant or any other person or entity, including, without limitation, personal injury or death to Eligible Entrant or any other person or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of a prize or participation in this Sweepstakes. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with participating in this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.
