

## Power Home Solar Giveaway

### Official Rules

#### NO PURCHASE NECESSARY TO ENTER OR WIN.

**1) Eligibility:** The Power Home Solar Giveaway (hereafter, "Sweepstakes") is open to legal permanent residents of the fifty (50) United States and District of Columbia who, prior to 10/26/19 are twenty-one (21) years of age or older (hereafter, each an "Eligible Entrant"). During registration, entrant will be asked to provide his or her first and last name, email address, birth date, gender (optional), to select a user name and password and accept the Terms of Use. Those who are already members of FanCompass will be asked to enter their account information (email address or user name, and password) to enter. As a member, entrant may enter the Sweepstakes by logging in to the system with entrant's current username and password.
