

2020 Panthers Inner Circle NFL Draft Experience

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The 2020 Panthers Inner Circle NFL Draft Experience Giveaway (hereafter, "Sweepstakes") is open to legal permanent residents of the fifty (50) United States or District of Columbia who, prior to 2/12/20 are twenty-one (21) years of age or older (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of Panthers Stadium, LLC, Panthers Football, LLC (hereafter, "Sponsor"), the National Football League, its member professional football clubs, NFL Ventures, L.P., and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void where prohibited by law. All applicable federal, state & local laws apply.

To enter, entrant must be a member of FanCompass.com. Registration is free. If entrant is not a member, entrant may register by clicking on the link as indicated on the Sweepstakes entry page and following the instructions. During registration, entrant will be asked to provide his or her first and last name, email address, birth date, gender (optional), to select a username and password and accept the Terms of Use. Those who are already members of FanCompass will be asked to enter their account information (email address or username, and password) to enter. As a member, entrant may enter the Sweepstakes by logging in to the system with entrant's current username and password. Entrants are responsible for ensuring that all contact information is up-to-date and accurate.

2) Promotion Period: Sweepstakes starts 10:00:00 am Eastern Time ("ET") on 2/12/20 and ends at 11:59:59 pm ET on 3/11/20 (hereafter, "Promotion Period").

3) How to Enter: During the Promotion Period, visit <https://contests.panthers.com/contest/3992> and complete and submit the registration form to receive one (1) entry ("Entry").

Entries must be received by 11:59:59 pm ET on 3/11/20 to be eligible. **Only one (1) entry per person will be accepted throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) are void. In the event of a dispute as to the identity of any entrant, such entrant will be deemed, to be the "authorized account holder" of the e-mail address submitted at the time of entry provided he/she is eligible according to these Official Rules. malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, emails or the announcement of the prize; or for any injury or damage to entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants whom Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

4) Winner Selection: The potential winner will be randomly selected from among all entries received throughout the Promotion Period. Drawing will be conducted by Sponsor on or about 3/12/20. Odds of winning the prize depends upon the total number of eligible entries received throughout the Promotion Period. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. The potential winner will be notified by telephone and/or email and will be required to execute and return an Affidavit of Eligibility, Liability and (where legal) Publicity Release within two (2) days of date of issuance of notification. Winner's guest must be twenty-one (21) years of age or older and must execute and return a Liability/Publicity Release. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

5) One (1) Grand Prize: The Grand Prize winner will receive a three (3) day/two (2) night trip for winner and (1) guest to Las Vegas, NV from 4/23/20 - 4/25/20 to attend the 2020 NFL Draft. Trip includes i) round trip coach class air transportation from a major U.S. gateway airport nearest winner's residence in the U.S. to Las Vegas, NV; ii) one (1) standard double occupancy hotel accommodation (one (1) room) for two (2) nights; iii) two (2) tickets each to Round 1 (4/23) and Round 2 (4/24) of the 2020 NFL Draft. Actual value of prize may vary based upon location of winner's residence. If the winner resides within a 100-mile radius of Las Vegas, NV, ground transportation (or other form of transportation) may be provided in lieu of air transportation at Sponsor's sole discretion, and no compensation or substitution will be provided for difference in prize value. Exact seat locations are at Sponsor's sole discretion. Trip must be taken on dates designated by Sponsor or prize will be forfeited in its entirety (and Sponsor will have no further obligation to such winner) and, at Sponsor's discretion, may be awarded to an alternate. Travel and accommodation restrictions and other restrictions may apply. Winner and guest must travel together on same itinerary and are responsible for obtaining all required travel documents prior to travel. All travel arrangements must be made through travel agent of Sponsor's selection on a carrier of Sponsor's choice. Released Parties are not responsible for travel delays or cancellations. In the event the Draft is postponed and rescheduled, the trip will be rescheduled. In the event the Draft is postponed and not rescheduled, no compensation or substitution for such portion of the prize will be provided; however, the remainder of prize package will be awarded, and Sponsor will have no further obligation to winner. The winner and his/her applicable guest must comply with all venue rules and regulations. Failure to do so may result in forfeiture of such portion of the prize and removal from event. Released Parties reserve the right to remove or to deny attendance

to any winner and/or guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the 2020 NFL Draft. The tickets are subject to the terms and conditions specified thereon. If unused, tickets cannot be returned, refunded or exchanged for cash value or substitute tickets. All prize details are at Sponsor's sole discretion. Prize is awarded "as is" without any warranty or guarantee, either express or implied by Sponsor. 8) Choice of Law: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the Mecklenburg County, North Carolina, USA.
