

## Christian McCaffrey Jersey Giveaway

### Official Rules

#### **NO PURCHASE NECESSARY TO ENTER OR WIN.**

**1) Eligibility:** The Christian McCaffrey Jersey Giveaway (hereafter, "Sweepstakes") is open to legal permanent residents of the fifty (50) United States or District of Columbia who, prior to 3/9/20 are twenty-one (21) years of age or older (hereafter, "Eligible Entrants"). Those who are already members of FanCompass will be asked to enter their account information (email address or username, and password) to enter. **3) How to Enter:** During the Promotion Period, visit <https://contests.panthers.com/contest/4045> and complete and submit the registration form to receive one (1) entry.

Entries must be received by 11:59:59 pm ET on 3/26/20 to be eligible. **Only one (1) entry per person will be accepted throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The potential winner will be notified by telephone and/or email and may be required to execute and return an Address Verification Form within two (2) days of date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

**5) One (1) Grand Prize:** The Grand Prize winner will receive one (1) autographed Christian McCaffrey jersey. Approximate Retail Value = \$67.50. Actual value of autographed jersey is subject to market fluctuations. Prize is awarded "as is" without any warranty or guarantee, either express or implied by Sponsor.
